Minutes

Present: Chairman Mark Richards (MR), John Adams (JA), Mary Carey (MC), Nicki Clarke (NC), Andy Salmon (AS) and County Councillor Anda Fitzgerald-O'Connor

19/164: Apologies for Absence: Vice Chair Liz Gilkes (LG), Councillor Stephen Day (SD) and District Councillor Jerry Avery (JA)

There was a discussion around whether the council needs to meet once per month. The council agreed to leave the schedule for now, but look to consider eliminating some meetings. It was noted that there could be a need for extraordinary meetings in between for items such as planning.

19/165: Declarations of interest: None

19/166: Public questions and statements: One member of the public was in attendance.

19/167: Reports from District and County Councillors:

Vale of White Horse District Council

There was no report.

Oxfordshire County Council (OCC)

AFO reported that there is winter advice for vulnerable residents on oxfordshire.gov.uk.

AFO reported there had been a program on County Lines shot in Oxford and recently aired.

AFO reported that the council is doing a trial of different types of road surfacing (with graphene). This is a 2-year project.

AFO reported that more money is being spent on the A40 from Witney to Eynsham. The dual carriageway will extend to Eynsham.

AFO reported the gritters have been out.

AFO reported that there is currently not funding available for VE Day celebrations, but may be something available closer in.

JA noted that there are still drainage issues where Oaksmere meets the A420. He noted this is a real concern in freezing temperatures.

AL noted she has e-mailed Arthur McEwen-James several times regarding the tree branches overhanging Jubilee Park from a resident's tree, but has never heard back. The council has also contacted the resident, but not heard back. AFO felt that it should be fine for the council to cut the branches, but the council requested a note to this effect from AFO. AL will e-mail AFO.

AFO reported there is still a little left in her Priority Fund. The council will look to ask for funds for speed signs pending the demo AL will be attending on 3/12/19.

AFO wished the council a Happy Christmas.

19/167: Minutes from the meeting of the 11th November 2019: The minutes from the meeting of the 11th November 2019 were signed and approved.

19/168: Matters arising from the previous meeting and not appearing anywhere else on the agenda: MC noted that she is working to get more information on the process of obtaining CIL monies.

19/170: Thames Path: AL reported she has e-mailed OCC letting them know about ACH's letter and asking them to follow what their normal process would be when a request such as this arises. OCC has e-mailed the address they had on file.

AL has e-mailed AH Cornish informing them that she has been in touch with OCC regarding his request. AL has heard nothing from either OCC or AH Cornish regarding the above correspondence.

19/171: Clerk's report: The Clerk's Report was noted. The council agreed for AL to destroy old planning applications which have been completed. The council agreed to AL purchasing a filing cabinet for the council which may eventually be able to be stored at the Village Hall.

19/172: Budget review: The council reviewed the draft budget for 2020/2021. It was noted that there are some items of potential expenditure added in such as speed signs and website costs. With these additional costs, the council was concerned about the precept being raised by 7%. AL will ask the Vale for an extension of precept approval until after the January meeting so the council can review further precept calculations to reduce this figure.

19/173: Village Hall: It was reported that there will be a handover meeting on 3rd December. The council asked for a report of the meeting as well as a list of committee members. The council also asked to be informed if there is a change in constitution.

19/174: VE Day Celebrations: It was noted that The Plough is happy to be a part of VE Day celebrations as is the PCC. The council agreed to do a shout out around the 10th January asking for help organising VE Day celebrations. It was also noted that a suggestion box in the shop VE Day celebrations ideas might be useful.
